

2026 SETFOA Registration

By registering for the SETFOA for 2026 you agree to abide by the standards, policies, and By-laws set forth by SETFOA. Payment of registration dues is your acknowledgement and agreement to comply with the following:

1. SETFOA By-laws and policies.
2. Members of SETFOA are expected to be held to a high standard of conduct both on and off the field. As such, the Board finds it in the best interest of the Association to adopt a policy addressing misconduct of members that may bring our professionalism into question. Any member arrested or summoned into criminal court to answer a criminal allegation, in any jurisdiction, shall be suspended immediately from SETFOA activity pending the disposition of said allegations. Said allegations shall include any Felony or any Misdemeanor involving theft or dishonesty. Once disposition in the allegations have occurred, the Board may vote to lift the automatic suspension, make the suspension permanent, or take any other action the Board deems necessary.
3. You agree to comply with the following guidelines for all SETFOA officials concerning participation in social media or other communications generally available to the public. "Social media" includes but is not limited to blogs, forums, and social networking sites, such as Twitter, Facebook, LinkedIn, YouTube, and Instagram, among others, whether for personal or business use. You must refrain from inappropriate comments such as ethnic slurs, personal insults, or obscenity, or use language that may be considered inflammatory or otherwise reflects poorly upon the SETFOA as an organization of fellow members. As with other aspects of your conduct as a SETFOA official, you should make every effort to remain neutral and impartial in your social media activity and other public communications with respect to TSSAA (Tennessee Secondary School Athletic Association) matters so as not to create any perceived or actual conflict of interest, or the appearance of favored treatment or a lack of impartiality. You will demonstrate respect for the TSSAA, SETFOA, its member schools, and their representatives in your activity on social media as defined above and other public communications. You will not use social media to criticize, support, or favor any SETFOA or TSSAA members, their employees, representatives, TSSAA events, games, teams, coaches, students, players or officials. You also must not use social media to convey information or discuss any aspect of TSSAA games you are assigned to officiate prior to, during, or after the contest including game administrators, coaches, teams and student athletes. Failure to comply with these guidelines may lead to suspension, reduction in game assignments, and up to and including termination of your membership with SETFOA as determined by SETFOA Board of Control and State Supervisors.
